

Field Trip Expectations & Safety Acknowledgement Form

- When your group arrives, the leader will check in at the ticket window while your chaperones and students receive a guick overview of expectations and safety.
- To prevent overcrowding, we will divide into smaller groups with a 1:7 student/chaperone ratio and tour the grounds in different directions
- I understand that students are to be assigned to chaperones and chaperones are responsible for students' behavior at all times.
- o I understand that students are expected to make good choices, be respectful, move at a leisurely pace, and use quiet voices. As the leader, I am responsible for reinforcing this.
- I understand that exhibit walls, ledges, railings, and benches are not playground equipment to jump, swing, run, or climb on.
- o **I understand that my group and I are responsible for** being at the assigned meeting locations at the correct times for lunch and departure.
- I understand that the students and I are representatives of our school/group and our behavior can positively or negatively affect future field trips for our school/group. If your group has poor behavior, your school may be prohibited from visiting the Museum in the future. (Strictly Enforced)
- I understand that the Museum is unable to store lunches or personal items. ALL food MUST be left on the bus/vehicle until your scheduled lunchtime. Outside food is not allowed on Museum grounds; water bottles are permitted.
- I understand that the pathways are marked for our safety. I will ensure that students stay on designated paths and do not disturb any plants or animals.
- I understand that my students and I are responsible for cleaning up our trash in the picnic ramada and on grounds. For the health and safety of our animals, please do not throw anything into the exhibits. You may be barred from future visits, depending on severity.
- I understand that students are to be considerate of each other and other visitors by not blocking paths and exhibits and by using quiet voices, especially indoors.
